Three Mile Island: Looking Back

PCN's special series, "TMI Accident: 40 Years Later," includes first-hand accounts from activists, journalists, industry officials, politicians and local residents. In one-on-one interviews, our guests shared their unique perspectives on the accident and the plant.

In this series, I aimed to give people a thorough understanding about what happened beyond the timeline and about the people and the politics behind the decision-making.

Here are some highlights of the most memorable interviews for me.

- In **Paula Kinney's** heartfelt recollection of being evacuated, she speaks about her in-laws asking her to burn her and her children's clothing because they feared radiation traveling with them. Forty years later, the story still brings a tear to her eye. She has no plans of letting the legacy of that day die.
- **Jim Seif**, Administrative Assistant to Governor Thornburgh at the time, recalls receiving one of the first distress calls from Three Mile Island before it was known to the public.
- **Robert "RB" Swift** was a new journalist at the time. He shares his story of driving to the plant with a friend to sightsee and not knowing the significance the plant would have on his life.

Producing this series has taught me about Pennsylvania and the spirit of persevering in the face of change and danger. I've heard stories about sadness and trauma, but also of courage and hope. These stories are everyone's story.
