SUBJECT: SUMMARY OF JULY 27, 2021, MEETING WITH EXELON GENERATION COMPANY, LLC REGARDING A PLANNED REQUEST TO USE CASE OMN-28, (EPID L-2021-LRM-0069)

On July 27, 2021, an observation public meeting was held between the U.S. Nuclear Regulatory Commission (NRC or Commission) staff and representatives of Exelon Generation Company, LLC (Exelon, the licensee). The purpose of the meeting was to discuss a proposed alternative to certain requirements in Title 10 of the *Code of Federal Regulations* (10 CFR) Section 50.55a, "Codes and standards," for the subject facilities. The meeting notice and agenda dated July 13, 2021, are available in the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML21194A138. A list of attendees is enclosed.

During the meeting, Exelon discussed a potential request to use Code Case OMN-28, "Alternative Valve Position Verification Approach to Satisfy ISTC-3700 for Valves Not Susceptible to Stem-Disk Separation." Exelon placed particular focus on expectations with regards to providing a list of values for the submittal.

Exelon stated that it intends to submit the licensing action soon after the meeting. It is noted that by letter dated August 5, 2021 (ADAMS Accession No. ML21217A117), Exelon requested NRC approval of the alternative of Code Case OMN-28.

Following the business portion of the meeting, members of the public were provided the opportunity to ask questions of the NRC staff. An Nuclear Energy Institute representative asked questions similar to the Exelon's position on the need for a valve list to be provided in the application. Public meeting feedback forms were not received.

No regulatory decisions were made at this meeting.
