Eric:

Thank you for your continued interest in the approval for Constellation Energy's Three Mile Island facility. In response to your recent phone calls and email, I asked Curt Sebastian to speak with our project review staff who are most directly involved with the project. Below are the answers to your questions as a result of those conversations:

1. No water use data has been provided by TMI-2 Solutions, because TMI-2 solutions does not hold an approval with the Commission. The metering plan submitted for TMI-1's approval requires that any water transferred to TMI-2 be quantified as such and reported to the Commission. No such data has yet been reported.
2. After reviewing our files, the Commission is not aware of and does not possess any contract that exists between Constellation Energy and TMI-2 Solutions regarding water use.

3. At this point, because there is not any use or movement of water by TMI-2 Solutions, there is no information in our files about how water will be transferred by TMI-1 to TMI-2, at this time. We did perform a compliance inspection on February 24, 2023 to assess the situation currently at the site. At that inspection, the Commission was informed that TMI-2 Solutions plans to use water for decommissioning activities **after** Unit 1 is decommissioned. As we've discussed, the limit for the amount that may be transmitted by TMI-1 to TMI-2 is established in Special Condition 24 of the renewed docket approval for TMI-1. This condition also addresses the possibility of TMI-2's water use needs exceeding the proscribed threshold and the required regulatory path for TMI-2 if that eventuality occurs.

Again, we appreciate your continued interest in the project and please continue to reach out to myself or Curt Sebastian if you need anything further.
